Keeping Up With Growth in the Rhine-Main Region

The area is characterized by economic strength and dynamism, and is noted for its large, complex construction projects. Frankfurt am Main – often referred to by the nickname *Mainhattan* – is known as Germany's *city of skyscrapers*. Frankfurt Airport is an international passenger hub. The city has developed into Europe's data center capital, with the world's largest internet exchange points. The main focuses of Drees & Sommer's Frankfurt office reflect this. The planning and consulting company has overseen the construction or refurbishment of a large number of the skyscrapers located in this largest city of the German federal state of Hesse.
